



SEND Report—May 2023

We currently have children 55 (17% of school) on the SEND register, an additional 32 children who we are currently monitoring (10.53% of school) and 13 children (4% of school) with an additional medical need. The number of children on the SEND register is on an incline. The number of EHCP's and EHCA's are increasing and are a concern in school.

- Current national figures show that we are **significantly above** the national average for EHCP's – we now have **3.9% of school** – **NA is 2.1%**
- Current SEND support is also above the national figures – we have **22.45% of school** compared to **12.6% NA**.
- Currently have **12 EHCP's**. We have just been named on an EHCP for a new to school child, who will start in Year 1 in September – this child has significant needs and will require full time 1:1 support.
- We submitted an EHCA for a child in Nursery and hope to move forward with an assessment before the end of the year.
- We have 4 further children in school who require EHCA paperwork to be submitted before the end of the year.
- We have successfully been re-awarded 90% 1:1 EYIF for a child in 2 Year Old Provision who has significant health needs, this will continue until December. We are currently receiving 100% EYIF for a child in Nursery who will move to Reception in September. We also have a child in school with a VI who received 100% EYIF in previous setting – this funding has not been transferred and will need reapplying for. These children will need EHCA's as they move through school.
- Parental requests for referrals to CAMHS for ADHD/Autism diagnosis continue to be very high.
- Parental requests for EHCA are also increasing.
- One child with an EHCP is not attending school – this is an ongoing situation and we are liaising with all possible agencies to source the best outcomes for this child.
- We continue to work with the SCIL team link teacher for advice and support for specific children – this is proving very useful support.
- Referrals to SALT are slow moving – we are currently waiting 3 or so years from referral.
- Support from the SEND team at Bradford continues to be sporadic. Phone calls/ emails are not returned.
